

## PROPERTY TAX DEFAULT (DELINQUENT) LIST

The declaration of default was due to nonpayment of the total amount due for the taxes, assessments, and other charges levied in fiscal year 2014-2015 that were a lien on the listed real property.

Tax-defaulted real property may be redeemed by payment of all unpaid taxes and assessments, together with the additional penalties and fees, as prescribed by law, or it may be redeemed under an installment plan of redemption.
