

RESOLUTION NO. R2024-39

**RESOLUTION OF THE BOARD OF SUPERVISORS,
COUNTY OF ALPINE, STATE OF CALIFORNIA
ESTABLISHING RESIDENTIAL SHORT TERM RENTAL LICENSE APPLICATION FEES**

WHEREAS, Alpine County Code Section 18.73.230, enacted with Ordinance 740-21, established a \$100 application fee for residential short term rental licenses and noted that this fee was not anticipated to fully recover the cost of administering chapter 18.73; and

WHEREAS, Alpine County Code Section 18.73.230 stated that the county shall conduct a fee study to determine the cost of administering chapter 18.73, and stated that if based on the results of the fee study the fees need to be increased, the county may increase the fee by way of resolution; and

WHEREAS, On April 16, 2024, Alpine County adopted Ordinance No. 756-24 amending the Alpine County zoning ordinance regarding County Code 18.73 – Residential Short Term Rental Regulations, repealing the \$100 application fee; and

WHEREAS, a fee study was conducted in April of 2024 by county staff which determined that in order to fully recover the costs of administering chapter 18.73 increased fees should be established;

NOW, THEREFORE, BE IT RESOLVED, BY THE Board of Supervisors of the County of Alpine, State of California, do hereby establish fees for residential short term rental license applications as described specifically in Exhibit A.
